## 2015 PETITE SIRAH HORSE HEAVEN HILLS – ZEPHYR RIDGE VINEYARD

2015 vintage is Thurston Wolfe's 14th release of 100% Washington State **PETITE SIRAH**, a rare variety for Washington State. Known as Durif in France, this variety was misidentified as a selection of Syrah when originally introduced into California. The vines were planted in 1998 at the Zephyr Ridge Vineyard in the Horse Heaven Hills. The 2015 vintage was one of the warmest on record, producing wines with lower yields and intense color and flavor. Harvested in late September at 25 Brix, the grapes were fermented in small open top fermenters for eight days and transferred immediately on light pressing to American and French oak (30% new) for malo-lactic fermentation. After 21 months barrel aging, the wine was bottled in July 2017. The resulting wine is dark red with intense aromas of spice, dark berries and coffee and a rich, smooth finish. 350 cases produced and released November 2017. Alcohol 15%.
